Course Description

This workshop is designed to help students develop the skills needed to write clearly and dynamically. The year-long course is based on the dual premise that writing is a form of thinking on paper and that —like a painting or sculpture—a written piece is a “made thing,” requiring structural integrity and thoughtful, original use of materials (in this case, language). Underlying this premise is the assumption that thought, and therefore writing, has an inherent structure that can be perceived by the writer and manipulated to produce a clear communication of what is thought.

The Workshop is linked to your Critical Inquiry, Art Matters and Foundation courses. Assignments for these classes will form the “text” for your work in the workshop. We will analyze a wide range of academic and creative writing (including our own). We will experiment with different structural and organizational strategies, sentence-level revision techniques, research methods and the nitty-gritty of achieving a tight, powerful final draft. We will write a lot. We’ll re-write a lot. And, since this is a writing course, we will read a lot. We’ll read as writers read: widely, deeply, critically and creatively.

Conferences

In addition to scheduled class meetings, students will meet with the instructor in small group and individual conferences. A schedule for these conferences will be created the first day of class.

Course Requirements

*You are expected to attend and to be on time for all classes and conferences. **Each missed class (conferences count as class sessions!!) will result in a lowered grade. More than 3 missed classes will result in a failing grade. Lateness in excess of 10 minutes will count as a “half absence.”** It is your responsibility to reschedule missed appointments.

*Staying current with assigned readings and essays; participation in class discussions; creating a supportive environment for other class members when they present their work.

*Final portfolio of assignments; portfolio will contain final versions and earlier drafts of selected essays and additional items to be discussed.

Selected essays and articles will be posted on Blackboard
